#### What data do we collect?

### How do we store your data?

We securely store your data on a web hosting platform which is provided by Bluehost. Any data you send to us through email will be securely stored within Google's Gmail email service.

# Marketing

You have the right at any time to stop us from contacting you for marketing purposes. If you



no longer wish to be contacted for marketing purposes, please make us aware through your chosen communication channel (e.g email, phone).

### What are your data protection rights?

**The right to rectification** – You have the right to request the correction of any information which you believe to be inaccurate. You also have the right to request the completion of data you believe to be incomplete.

**The right to erasure** – You have the right to request us to erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request us to restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to us processing your personal data, under certain conditions.

**The right to data portability** – You have the right to request that we transfer the data we have collected to another organisation, or directly to you, under certain conditions.
